**1. ONLINE at Horse Show Office**

After entering and paying, download the entry and upload the Entry Form signature page, Vaccination Record (EHV4-1 within 6 months of April 10th and Coggins Report (Recorded date within 1 year of show) to Horse Show Office to complete the entry.

**Awards:**

- All classes will be separated into Seniors and Junior/Young Riders if there are at least 3 or more riders in the class. Championship classes will be separated into Seniors and Junior/Young Riders.
- First through Sixth place ribbons will be awarded for the schooling show classes. Championship classes will be awarded Champion, Reserve Champion and 3<sup>rd</sup> through 6<sup>th</sup> place ribbons. Trophies/awards are TBD.
- A Dressage High Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the highest score (Classes 1 through 12). A Combined Training Low Score Prize & Ribbon will be awarded to the SCDCTA Member / SCDCTA Reg. Horse Pair with the lowest score (Classes 13 through 18). **Attire:** An ASTM Approved helmet must be worn AT ALL TIMES when mounted and footwear should have a distinguishable heel while riding. Otherwise, casual attire is acceptable.

**Arenas:** Two (20m x 40m) dressage arenas will be used for Classes 1-3 and 13-19, 25-26. Two (20m x 60m) dressage arena will be used for Classes 4-12 and 20. A separate jumping arena will be used for combined test stadium and jumpers.

**Guest Horses:** Horses **NOT** entered in classes but attending the show must have a completed entry form (for each horse) by the closing date (4/5/21) and a current negative Coggins Report and vaccination record included. The Liability clause must be signed by rider/handler of the horse on the entry form. The fees for each guest horse are \$25.00 and a \$15.00 office fee (add \$5 to the office fee if entry is emailed.) Each guest horse is required to wear a number when off the trailer or out of a stall. The number is obtained at the Check-in Table. Late fees apply if requested after 4/5/21.

**MPEC April 10, 2021 Championship Classes:**

Horse/Rider Pairs that are **eligible for championship classes** will be notified by email by the opening date of the show. Championship classes will be listed separately on the April 10, 2021 Schooling Show prizelist.

**Eligibility requirements:**

- Participation in two of the four shows qualifies a rider/horse pair to compete in the MPEC April Championship classes.
- Rider and horse must show as a pair throughout the MPEC show series. Show dates are 9/19/2020, 11/7/2020, 1/9/2021 & 3/13/2021.
- A rider/horse pair can compete and become eligible in both Dressage, Combined Training, Jumpers and DSE.
- A rider/horse pair may only compete in the Championship class(es) for which they are eligible based upon the level(s) shown at the MPEC Show Series listed above.
- Championship classes will be separated into Jr/YR and Sr divisions. Championship classes include: Introductory through Fourth Level Dressage Tests, Amoeba through Training Combined Tests, Intro Jumpers through High Jumpers, DSE W/T and DSE W/T/C if there are at least three eligible riders for the class.
